APPOINTMENTS/CANCELLATIONS

Please remember to cancel or reschedule your appointment 24 hours in advance to avoid any fees/charges. Should you choose not to cancel 24 hours in advance, you will be responsible for the full visit fee based on the credentials of your clinician (review the fee schedule).

If you have an EMDR appointment that is usually an hour and a half, your late cancellation fee will be \$100.00. This is necessary because a time commitment has been made to you and is held exclusively for you. It is important that you attend your sessions on time. Please keep in mind that if you are late, your clinician cannot extend the session to accommodate the full 45 minutes. Lateness creates challenges to your therapist in their ability to provide the best possible care for your and other clients.

The standard meeting time for psychotherapy is 35-45 minute sessions. It is up to you, however, to determine the length of time of your sessions. Requests to increase the time of your sessions to 60-minutes must be made to your therapist in advance. Keeping in mind that some therapists cannot accommodate the requested change due to prescheduled clients.

It is expected that you will upload your credit card information or FSA Card or Health Savings Card to the portal and it is your responsibility to keep up to date. Should we be unable to reach you to process copays and other payments, there will be a 3% charge added to your fees.

TELEPHONE ACCESSIBILITY

If you need to contact your therapist between sessions, please leave a message on our automated number, 631-440-1080. Your therapist will reach out to you within 48-hours. Please keep in mind that often our clinicians are in-session and cannot address your call immediately. Should you have an emergency, our recommendation is to go to the nearest emergency room or contact 911.
